
CHAPTER: 4

Classification of Law.



Legal rules are divided into rules of public law, rules of private law, and other rules that are difficult to define, or what is known as mixed law.

- 1. Public law and its branches.
- 2. Private law and its branches.
- 3. Mixed law and its branches.



LAW CLASSIFICATION SCHEME

1. Public law and its branches:

Public law is the set of rules that regulate relationships whenever the state is a party to them as it has authority and sovereignty. Public law is divided into international public law and internal public law:[1]

- A. international public law: It is the rules that regulate relations between countries in times of peace and war, Or between the state and one of the international organizations. [2]
- **B.** internal public law: Legal rules related to public administration, organization of administrative devices and their activities, administrative means (material and human), and their disputes. [3]

 - Financial Law.
 - Criminal Law: Penal Code. // Code of Criminal Procedure.
- 2. Private law and its branches: The rules that regulate relations between individuals, or between them and the state as it does not exercise sovereignty. [4]
 - civil law.
 - Commercial Law.
 - Family law.
 - Private international law.
- 3. Mixed law and its branches: They are laws that combine the rules of public law and the rules of private law.
 - Code of Civil and Administrative Procedures.
 - work law.
 - Maritime Law.
 - Air law.
